## **Delivery Areas & Fees**

• **0–5 km:** Free delivery

• 5-10 km: Free delivery for orders over R1000

• 5–10 km orders under R1000: Charged per the R5/km rule

• 10 km+: R5 per km (customer will be contacted on WhatsApp to confirm exact amount)

### **Delivery Times**

• Standard: Next-day delivery

• **Speedy:** Within 4 hours (additional fee may apply)

### **Delivery Conditions**

- Customers must ensure someone is available to receive the delivery.
- Failed delivery attempts may incur re-delivery fees.
- Meat must be refrigerated immediately after delivery; Hokaai is not responsible for spoilage caused by late collection or failure to refrigerate properly.

### 6. In-Store Pickup

- Orders can be collected in-store during trading hours.
- Proof of order may be required.
- Meat must be collected promptly to avoid spoilage.

#### Requirements

- We only accept skinned meat
- Gut-shot meat accepted
- No green, rotten, or home-killed meat accepted
- Valid hunting permit required

## **Processing Rules**

- KG in = KG out principle
- Client must specify processing preferences
- Additional services available (see pamphlet)

## **Pickup Requirements**

- Client has 2 days from notification to collect
- After 2 days, **R200/day storage fee** applies
- Meat left uncollected after 6 months will be discarded
